A resolution confirming the preliminary design of Lincoln Street from 29th Avenue to 17th Avenue (Manito/Cannon Hill Neighborhood Council)

BACKGROUND:

The Manito/Cannon Hill Neighborhood requested that the Lincoln Street from 29th Avenue to 17th Avenue project be delayed from 2008 to 2009 to allow discussion options with the City. This request was granted. Subsequent meetings resulted in the City estimating four alternatives and presenting them to the Neighborhood. Alternate #2, was selected and uses curb extensions to treat the first 1/2 inch of stormwater before discharging it into the combined storm/sanitary sewer system, and will also slow the peak discharge and reduce CSO overflows into the Spokane River. In addition, the curb extensions act as traffic calming devices.

A RESOLUTION confirming the Preliminary Design of Lincoln Street from 29th Avenue to 17th Avenue.

WHEREAS, the Manito/Cannon Hill Neighborhood requested that the Lincoln Street from 29th Avenue to 17th Avenue project be delayed from 2008 to 2009 to allow the Neighborhood to discuss options with the City. Mayor Hession granted this request; and

WHEREAS, subsequent meetings resulted in the City estimating four alternatives, and presenting these four alternatives to the Neighborhood; and

WHEREAS, alternative #2 was chosen by the Neighborhood. This option uses "curb extensions" to treat the first one-half inch of stormwater before discharging it into the combined storm/sanitary sewer system. This option will also slow the peak discharge, and reduce CSO overflows to the Spokane River. In addition, the curb extensions act as traffic calming devices; and

WHEREAS, the Neighborhood would like the City to construct option #2; -- Now, Therefore,

BE IT RESOLVED that the City Council, for the City of Spokane, confirms that design option #2 is used for Lincoln Street from 29th Avenue to 17th Avenue.

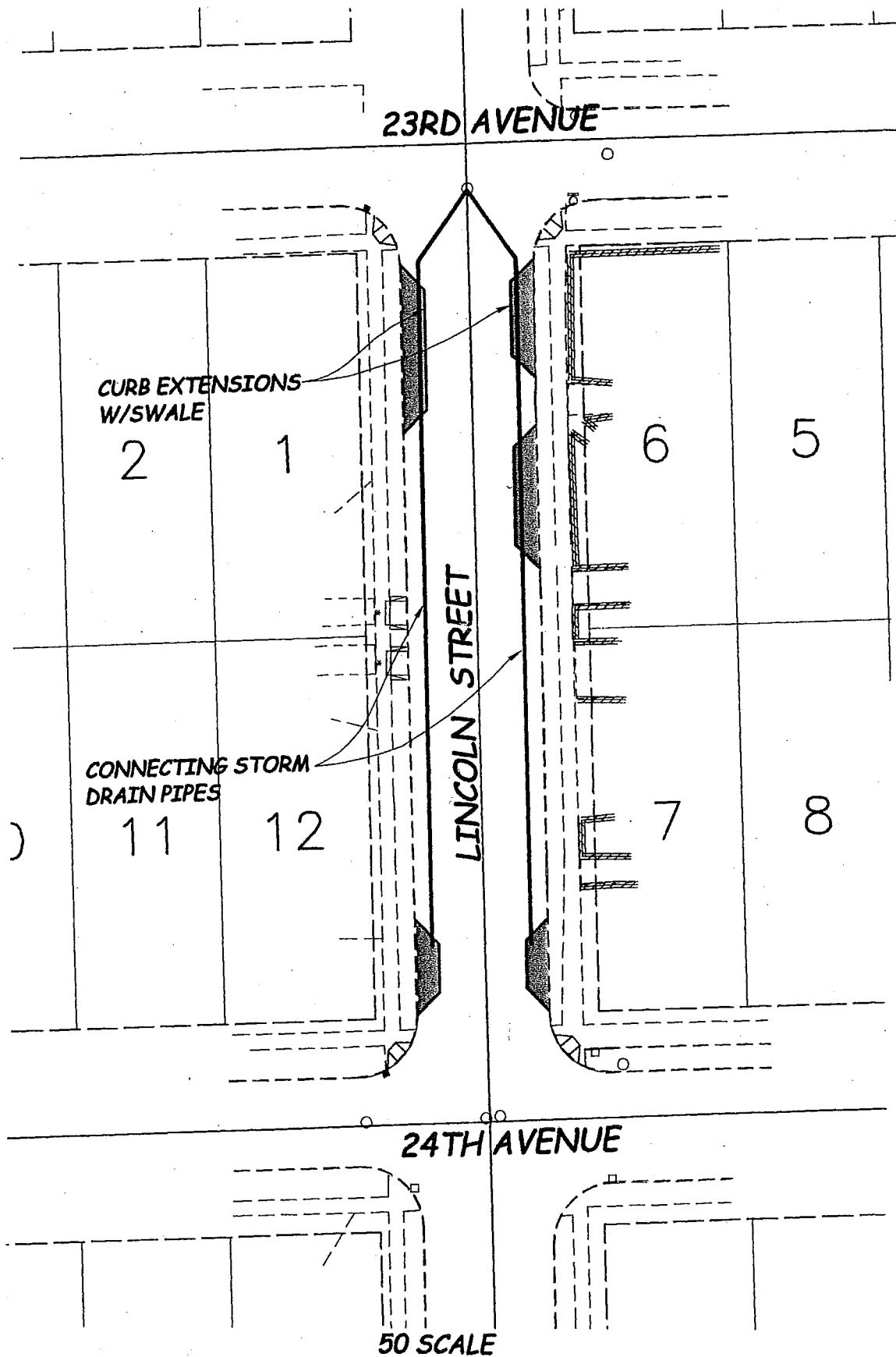

1	Widen planting strip, reduce street width by 2 feet, each side	\$700,000	Neighborhood
2	Curb extensions and swales sized to treat first one half inch of runoff	\$1,050,000	Wastewater
3	Curb extensions and swales sized to treat first one half inch of runoff plus bump outs at intersection corners	\$1,740,000	Wastewater \$1,050,000 Neighborhood \$690,000
4	Curb extensions for tree planting only and bump outs at intersection corners	\$870,000	Neighborhood
